CODE MEDIATOR FOR ALDI 2024-2025 ANNUAL REPORT

Introduction

As a 'large grocery business' operating in Australia, ALDI Stores (A Limited Partnership) ABN 90 196 565 019 (**ALDI**) is subject to the requirements of the Food and Grocery Code of Conduct (new Code) prescribed under the *Competition and Consumer Act 2010* (Cth) and set out in the *Competition and Consumer (Industry Codes – Food and Grocery) Regulation 2024* (**Regulation**).

Under the new Code, ALDI is required to appoint a Code Mediator. On 1 April 2025, when the new Code came into effect, I was appointed by ALDI as its Code Mediator. Prior to this, I performed the role of Code Arbiter for ALDI under the old Code that was in force immediately before.

Annual reporting requirements

As the Code Mediator for ALDI, I am required under the Regulation to prepare a written report in respect of each financial year. This is my first annual report in the capacity of Code Mediator for ALDI. Under the transitional provisions for the Code Mediator's first annual report, the report to be prepared must be for the 2024-2025 financial year.

Subsection 59(2) of the Regulation lists the content requirements of the annual report to be prepared by the Code Mediator.

Time frame

The Code Mediator for ALDI is required to prepare the report and give copies to ALDI, the Australian Competition and Consumer Commission (ACCC) and the Code Supervisor within 30 business days after the end of each financial year.

I confirm that I completed my report for the 2024-25 financial year on 23 July 2025. I also confirm that copies of my report were provided to the ALDI, the ACCC and the Code Supervisor on the same day.

2024-2025 Report

This report is verified to be accurate for the purposes of annual reporting by the Code Mediator for ALDI.

Ways the Code Mediator has assisted suppliers during the financial year
